Driver blames potato chip in Old Fort crash

With the fence around the Arrowhead Monument repaired, the town of Old Fort is now trying to put its Nativity scene back in place in time for Christmas.

On Monday at 8:45 a.m., Larry Gipson, 58, of Clayton, Ga., was driving his 2010 Dodge pickup truck east on Main Street in Old Fort. Gipson told police he was eating some some shrubbery and a bench potato chips while driving and one

him to black out. The truck went off the street, traveled through Bradley Park and struck the town's Nativity scene, according to Police Chief Melvin Lytle.

The accident took out Baby Jesus, Mary and Joseph. Two shepherds and some sheep appeared to be unharmed.

The truck also hit the rock work, dedicated to the memory of Linda

of them lodged in his throat, causing Bunch, one of the founding members of the Old Fort Mountain Heritage Alliance. The nearby gazebo was not hit. Lytle said he estimated the damage to the park and its contents at around \$6,000.

No one was injured in this incident. Gipson was charged with reckless driving. The damage to his pickup is estimated at \$15,000, said Lvtle.
